Ethiopia says Nile dam will go ahead regardless of impact study

Construction of Ethiopia's controversial Grand Renaissance Dam on Nile River will go ahead whatever the findings of an environmental impact report agreed with Egypt and Sudan, the government said Wednesday. "This study cannot affect construction of the dam.
Construction of the dam will continue,"
Mutuma Mikasa, minister of water,
irrigation and electricity, told a news
conference. He spoke after returning
from a meeting in the Sudanese capital
Khartoum, where two French
engineering firms signed a contract to
conduct an environmental impact study
in the presence of top diplomats from
Egypt, Ethiopia and Sudan.

Egypt, Ethiopia, Sudan sign final contracts on Nile dam studies

Egypt, Ethiopia and Sudan have signed the final contracts for the long-awaited technical studies on the impact on downstream countries of a giant dam that Ethiopia is building, Egypt's state news agency MENA reported. The signing that took place in Sudan's capital Khartoum on Monday was made with French consultancy firms BRL and Artelia, as well as British law firm Corbett, which will carry out studies on

Regional powers back studies on impact of Ethiopia's Nile dam

Egypt, Sudan and Ethiopia commissioned studies into the environmental and economic impact of a \$4 billion dam on the Nile that Addis Ababa aims to make the centre piece of its bid to become Africa's biggest power exporter. The 6,000 MW Grand Renaissance Dam, situated close to Ethiopia's border with Sudan, and being built by Italy's largest construction firm Salini Impregilo, is due for completion next year.

French firms to gauge impact of Nile dam project

Two French engineering companies formally signed a contract in Sudan on Tuesday to conduct environmental impact studies on Ethiopia's Grand Renaissance Dam project on the river Nile, officials said. Artelia and BRL were chosen late last year to carry out technical studies on the project after a meeting of top diplomats from Egypt, Ethiopia and Sudan. BRL director general Gilles Rocquelain told AFP after the contract was signed in Khartoum that the studies would begin after two months and "take 11 months to complete".

Egypt, Sudan, Ethiopia sign agreement to conduct technical studies on Grand Renaissance Dam

Egypt, Sudan and Ethiopia signed an agreement on Tuesday tasking French consulting companies BRL Ingenierie and Artelia with conducting feasibility studies on the Grand Ethiopian Renaissance Dam (GERD), state news agency MENA reported. The three



countries' irrigation ministers and Egypt's ambassador to Sudan were present at the signing in the Sudanese capital Khartoum. In line with recommendation from the 10-member International Panel of experts established by the three countries, the feasibility studies will include an assessment of the dam's environmental, socioeconomic and ecological impacts. http://bit.ly/2dcLEwy

Egypt, Sudan, Ethiopia sign final contracts on dam technical studies

Egypt, Sudan and Ethiopia have officially signed the final contracts for the technical studies to be conducted on the Ethiopian Renaissance Dam, Aswat Masriya reported on Tuesday. The contracts were signed on Tuesday by the three nations and the two French consultancy firms conducting the studies and an English law firm overseeing the legal arrangements. The documents were signed in a ceremony at a hotel in the Sudanese capital Khartoum.

Siaya's Lake Kanyaboli: A beauty enclave faces peril

[...] The 1,000-hectare Lake Kanyaboli, is one of the three components that make up the phenomenal Yala Swamp complex. The other two features are wetlands in the delta of the Yala River and Lake Sare, one of several outlets of the Yala River into Lake Victoria. [...] However, all is not well for the lake, the swamps and the entire ecosystem. Environmentalists have sounded the alarm that the water levels in the three metre deep Kanvaboli is slowly receding, thanks to human activities and a harsh climate. The nearby swamps are being burnt at a fast rate by people seeking farming land and to remove fish hiding beneath the vegetation. Sitatunga, an animal in the antelope family, is not safe either. It is hunted heavily for food. http://bit.ly/2chaKnQ
